Dear Sir / Madam,

Thank you for the offer of an appointment at the North Road clinic. (encl.) As previously explained in my earlier letter (also copy encl.) Please would you cancel the appointment, thank you.

I ask you to understand: following the service given me by Mr M. Kulshrestha (the consultant) and Dr. R. O. Paul. In Aberystwyth Network; I am no longer able to trust these services. (Be at my Peril) Their services were extremely damaging on me, their patient at the time. Their treatments can be stated as needless deliberate sadistic and criminal. Pointlessly reported to the NHS GMC & Police.

They all contradicted a professor and peer consultants. Medical papers **specifically** condemn their prescriptions, as to cause blindness, pain, & strokes. And you ask me to return to all this Insanity! I can not trust you. Nor the organisations. Dear Sir / Madam,

Thank you for the offer of an appointment at the North Road clinic. (enclosed) I understand this is most likely in respect of your previously provided "eye services"- because it refers to the "Team in Ophthalmology." Please correct me if I am wrong in this, if it is meant to refer to something else?

If in fact it does refer to clinical eye services, please would you cancel the appointment, thank you.

In explanation: I have previously found the services of two doctors at the North road clinic, - Mr M. Kulshrestha (consultant) and Dr. R. O. Paul. (Assistant) Inconsistent with GMC directives. Extremely damaging upon me, their patient at the time. Their treatments can be accurately stated as needless, deliberate, sadistic and criminal. I reported them to the NHS the GMC and the Police.
