Dear Mr Austin,

Thank you for your kind understanding offer of an appointment at Glangwili, or North Road clinic. Please accept my apology for not wishing to attend. May I explain: Two reasons.

1. Until the hospital consultants in Aberystwyth and Glangwili can believe me and accept the truth and enormity of exactly what your consultant colleagues did to me, I find it impossible to trust them. Such is, the water tight network of conformity among doctors the GMC and the Police. Omnipotent.

Naturally this is very difficult. Even as true, I cannot expect you to write ill of your colleagues. Until they, the GMC, and the Police, are able to show they believe me now and, have the will to correct this, by the removal of these two "doctors" off the medical register. (To protect their future patients.) I have tried all that I can to do. They all deny me. They lied to me, and about me. Slander & Libel. To stand alone, against a united and powerful evil enemy, when blind & in terrible pain is not easy. They **made** me blind and, refused to correct it; their patient at the time. My G.P. helped me recover. They compounded and confirmed their felony with an 80 min. continuous MRI head scan and a stab into my eye, to disconnect the optic nerve, or similar. Their combined needless, treatments can be described accurately, and truthfully, as deliberate, sadistic, and criminal! (extreme pain and blind.) They contradict many profs. and peer consultants. Medical papers do **specifically condemn** their prescriptions as to **cause** blindness; with never-ending pain and likely stroke. They tried to **kill me**. You invite me to return to this? When you band together, when supporting honestly described **EVIL**?

2. Following your completion of No.1. I would ask you for a written guarantee of my safe conduct for a visit please. You may easily repeat what they did to me, and more. Your department can inflict terrible harm. With no redress, nor from the organisations who would stand by you. Yes, you also could easily kill me and likely, get away with it. If I have your written promise for my guaranteed safe unharmed return I would hope you keep your word and, have some tangible evidence if you fail me. The police refuse to investigate; refuse to enforce the law; their law is only, whatever they say it is.

As an equal, may I suggest you ask him? **Why** did he prescribe Lumigan at bedtime? If he denies this, he lies. I have proof tell him - then ask him again, on oath. He may confess to you, alone? Ask other consultants, or the GMC, what time of day did their directive recommend for Lumigan eye drops? When they say "**no later** than evening" ask him **why** "he specified **Bedtime**"? **Repeatedly**. Ask him **why** did he order multiple MRI head scans to **exceed** the GMC directive **limit** of 60 min's? His scans took 80 minutes, a continuous excessive "**double dose**" of a normal 40 min's. duration! Ask Dr Paul **why**, in a pretence of an E.P. test did he stab right into my eye, to ensure I was blind? Mechanically blind, and then, in severe pain? Night and day, terrible! **Why** should a consultant have the **necessity** to say his patient is a "druggo?" Demands medication? has missed appointments etc? **ALL** of which was untrue. Simply made up, to create an excuse to get rid and discredit me. **All Lies**. I ask you to **form your own opinion**, then you may be able to understand and help me. Thank you. Jerome Thomas. I have nothing to gain, my aim is only to stop others like me being hurt, by them.

Dear Mr Austin, Page 2 continues. Please allow me to confirm your sequence of events:
The Optician tested my eyes and found no faults at all. Only a slightly high e.p. of 22.Ish.
He said he was legally obliged to refer me to the local Aberystwyth eye clinic. I duly attended.
The Consultant tested my eyes and said the e.p was 24-26 ish and that without eye drops I would suffer Glaucoma. He prescribed the drops, Lumigan, one in each eye at bed time. I did as he said.
This went on for a few weeks and at each re-examination he repeated this prescription, at Bedtime.
It is worth noting that before his "service" my eyes were perfect. I could read down to the bottom Line of the eye chart with both eyes separately, a newspaper from several feet away, put 5 rounds of 303 bullets in a 1 inch circle 200 yards away. Et. For my age, 73, both my eyes were "perfect."

On the 29th October I awoke blind. Just like that! No pain nor trouble, simply no sight. A mosaic of Greys in a zig zag pattern. Panic! I could not see: to get dressed, do my work, not even the food to eat on the table. I was lost, in a sea of blindness. My G.P. arranged an immediate appointment at the clinic (same day) and I returned to see the consultant. He said: He could do nothing for me! Aghast I said please help me. I had followed his instructions - and now blind! He said go home! I managed to get some sight back in one eye (only) and went on the Internet. I read of Professor Hayreh who had spent a life time on sight problems. He said Lumigan did prevent Glaucoma, providing it was NOT used at bedtime - because it would cause "awakening blindness." He also recommended a cure, "Prednisolome" I showed these medical papers to the consultant and - he scorned them. Refused to give me the cure, and said "go home, you will soon be completely blind."

My G.P. allowed me to have the "cure" and it worked immediately. Thank God! My sight was back! The consultant now became extremely angry at this, saying he would "have words" with my G.P. Coincidence, or not, my young G.P. had to take "early retirement" soon after this comment. True, Profs. Hayreh had explained Pred. will increase the eye pressure - to remove the dead cells, But - it could then be reduced to normal and, was far far more preferable to being blind! This is when the consultant said my ep was 38 and blamed me, for the Pred.. To cover his tracks. He said he wanted an MRI head scan, perfectly safe, like an X-ray. He said. I gave to his knowledge and attended his MRI scan. The scan was continuous, from 9.10 a.m until 10.30 a.m. by the wall clock above the door. Upon completion I could not get off the table. Could not stand up, and had to rest awhile. I asked the lady radiologist who had scanned me, "why had it taken so long?" My head had been strapped in a cradle and the machine had buzzed, buzzed, buzzed, seemingly forever. She replied: "the scans were ordered by the consultant who wanted them from different angles; you will have to ask him about it." Within the hour my head was "bursting" and bound together by a "Steel band" with pain and more pain. Forever. 3 Years this lasted. I took more anadin & asprin etc than I had in the rest of my whole life!. Then, Dr Paul said he wanted another ep test. He put anaesthetic in my eyes, put my head on the cradle. Attached something to the machine, and stabbed into my right eye; took it off the machine, pocketed it, and left the room. All in 1 minute.! The eye pain lasted several months. Night & day, blind with head pain, No one should suffer this. Consultant now reported I was a druggie, who had demanded medication violently, and had missed several appointments (all lies) and the clinic said "I would have to re-apply for treatment elsewhere." I did, and went to Carmarthen for help, please! The consultant said he could not help me. Good Bye. I wish I had never ever meet them. I had good eyes, was healthier and happier. They ruined my life.

Dear Sir / Madam,

Thank you for the offer of an appointment at the North Road clinic. (enclosed) I understand this is most likely in respect of your previously provided "eye services"- because it refers to the "Team in Ophthalmology." Please correct me if I am wrong in this, if it is meant to refer to something else?

If in fact it does refer to clinical eye services, please would you cancel the appointment, thank you.

In explanation: I have previously found the services of two doctors at the North road clinic, - Mr M. Kulshrestha (consultant) and Dr. R. O. Paul. (Assistant) Inconsistent with GMC directives. Extremely damaging upon me, their patient at the time. Their treatments can be accurately stated as needless, deliberate, sadistic and criminal. I reported them to the NHS the GMC and the Police.

Sadly ALL these organisations refused to protect future patients from their prescriptions, which I do accurately and truthfully confirm, irrevocably as their victim, will induce blindness, severe pain, with their ultimate intention to cause anyone, via a grossly excessive MRI head scan, a stroke or death.

These organisations did, arrogantly, dismiss all my letters of appeal, with contempt and perversion.

Every patient they deliberately mal-treat is now, down to these officers. I have tried my best to save others from their prescriptions. They contradict professor and peer consultants. Medical papers do specifically condemn their prescriptions. Notably, well known to cause blindness, pain and strokes.

I have recovered my eyesight in one eye. Twice I have escaped their evil machination! Understand I am fearful to return to you, for a *third dose*! What good can you do? Perhaps complete their work! God and my G.P. saved me. Against stupidity (my returning to you) even the Gods would struggle.

They made me blind; prescribing Lumigan drops at bedtime. Then tried to kill me, via a stroke, by ordering a grossly excessive **80** minute multi-MRI head scan; and then stabbed my eye into severe pain and mechanical blindness in their pretence of an e.p. test. I ask, is this valid medical service? Despite over whelming evidence; medical papers; witnesses; GMC directives; etc. the GMC and the Police allow these men to continue!
