Dear Mr Austin, Sir,

Thank you for your letter of the 8th Feb. 2023. Considerate as it appears, it disappoints me. I had hoped, you being an equal to the doctors of which I complained, you may have understood and believed me. Too much to hope there. I explain:
Your first sentence "Given that you have had treatment for Glaucoma for a number of years..." Leads me to believe a) you believe them, not me. And b) at best, you fail to understand at all.

I have never had Glaucoma. I was instructed by my optician, who said "He was legally obliged to refer me to the clinic with an EP of 22." How true was his statement I do not know; I just trusted him. Please see attached a NHS publication regarding this. The consultant Mr M. Kulshrestha insisted that he could not help me with Glaucoma IF: I did not accept his prescription of Lumigan at bedtime. He did not find nor say I had ANY Glaucoma in my eyes. Only his threat - that if I refused Lumigan it could develop. Trusting him, without question, I applied the lumigan, exactly how he prescribed, one drop each eye at bed time. It was needless. My eyes were perfect, but he made it very clear to me that, if I refused to do as he said, - I could go blind with Glaucoma. Which he c/would not cure.

His prescription was in error. The GMC directive was " To be applied **NO LATER** than evening." But I did not know that then. He did; and as a consultant, expected to know this; prescribing it daily. This was deliberate; with his expectation of my blindness to follow; it did. And he refused to help me. Had he said e.g. Take these pills, and all will be well. Or, sorry about that, I will correct "awakening blindness" I could have believed it was accidental. And the matter gone no further. But he refused; he wanted me this way; Blind. Like the scores of other elderly patients in degrees of blindness; all of them queuing for hours in the corridor awaiting his specialist "services" due to block bookings.

You may understand my dislike now distrust of these two doctors. Indeed also the GMC and Police, who blatantly lie to me; spin for effect; and make smoke in their corrupt support of their actions. e.g: Professor S Heyrah, a man who has spent over 30 years, with over 1000 patients, had written **approved** medical papers over an " inch thick" of detailed proof in full support of his studies was denigrated, by the GMC, as to be of no justification for my complaint for being, and here I quote: **".. just an article I had read some were..** " This illustrates how they deny a victim. When the GMC Executive and Med. Examiner, already **knew** it was the basis of their own directive! They lied to me.

The Police are no better. From when I report these crimes: Witnesses have been given "retirement" the actual MRI scanner has been removed; even the clock on the wall taken away, and my report of their crimes was "lost." All investigation refused. My judicial appeal intercepted and dismissed. The IOPC and IPCC all decided it was for "local resolution" - by the persons who refused it initially!

These were serious deliberate crimes of GBH and attempted murder. By doctors who knew what they did; deliberate; with no duty of care. The GMC lied in support of them, the Police obstructed and perverted justice. With all this corrupt support they know themselves to be unaccountable. You invite me to return to this? Never again can I respect and trust, in all innocence, a consultant. They **all lied**, to a man. To protect these two errant doctors, who have disgraced your profession.

All **liability** has been removed from my shoulders. I sleep soundly now in the knowledge I have done my best with the NHS, GMC, and Police, to see they are stopped. To no avail. For all these are now **complicit accomplices** to their crimes. The liability responsibility is totally theirs. Not mine.

They have inherited their world; of letting them do whatever they like to others, with impunity. No redress nor justice is allowed by them. And, what they do **will** come around, to them also, one day. Or a close relative, or friend they know. Because, these doctors are inducting junior doctors into their Evil ways. I know; I have met some of them; and they readily affirm their actions to be right!

Even if you believed me; if you knew, or accepted as true what I say, what can you do about it? The forces are far too great for you to succeed, ever. Which is how they win. All it takes for evil to succeed is: Good men to do nothing. That is *exactly* what they are doing, nothing. Dismissed.

Whistle blowers should be applauded and commended for having the courage (stupidity?) to speak up. Not denied, not lied to, not refused justice, and certainly Doctors not allowed to continue. In the past **ten years** I have struggled to survive, blind and in pain, self employed, with a wife and four grown up children. These doctors and officers of the GMC and Police **collectively** have taken home, from the public purse (our taxes) **millions** of pounds, for refusing to do their job!

Who's barmy? Sorry, I have no other "song" Only the truth, and hope, to save others.
