Thank you for your kind and understanding offer of an appointment. Unfortunately I am unable to attend due to my previous unpleasant experiences from this service. I have been extremely lucky to escape the traumatic “treatment” of the previous visits and without your confirmation the two doctors concerned have been removed from the medical register for mal-practice and dishonesty I am too afraid to go through it ever again. This, is the real **tragedy** of their mal-practise.

Briefly: He **made** me blind with his incorrectly timed prescription (knowingly) and, when I naively tried to inform him of his error (believing it to be an innocent mistake) he tried to murder me! (Criminal) Then: He attempted to hide his criminal acts with a continuous, double duration, grossly excessive, MRI head scan of 80 minutes.
