I ask your Lordships to review and correct the decisions of: 1. The General Medical Council. 2. Dyfed-Powys Police for my case. Specifically: 1. To instruct the GMC to acknowledge and confirm: the defendant Doctors did, in fact, **fail to comply** with the directives of the GMC. 2. To instruct the Dyfed-Powys Police Officers to acknowledge and confirm what these defendant doctors did were **serious crimes** - of Grievous Bodily Harm and attempted Murder (by proxy) acted upon me, and, they should have investigated and charged them.

However, I *sincerely* apologise for contacting you, of necessity. I will be brief, and not delay you for too long. Truly, I can find **no Justice** in the Dyfed-Powys Police force. Only **Obstruction** and **Perversion** of Justice. I progressed to these officers via the GMC. A dysfunctional organisation. One very heavily biased in favour of the doctors. In proof please see enclosed, a copy of my last letters to them both, after years of writing. Briefly:

I am not financially wealthy nor influential. Just an ordinary working man, whom is extremely grateful for the state pension. I have lived a happy and productive life. My wife, children and grandchildren, all love me. For this I consider myself rich beyond measure, and, have no wish to write disparagingly about anyone. However: These two men, doctors, have attempted to ruin these last years of my life, exposing what they do. I can show their practices were deliberate; sadistic; and incompatible with the GMC directives. Contrary to the many published medical papers, of which he admitted, he was well aware. (see Prof. Hayreh. et. encl.) If you need an independent second opinion; please ask any qualified eye consultant these two questions:

- 1. Would they prescribe Lumigan eye drops to be applied at **bedtime?** Yes, or No? And, why not?
- 2. Would they prescribe a *continuous* MRI head scan of duration <u>80 minutes</u>? Yes or no? And, why not? The above, these doctors used to "treat" me. Result 1. To blind and, 2. To kill me. (by a stroke, embolism et.)
- 3. The eye stabbing of Dr. R.O. Paul, and manner in which he executed it speaks for itself. Cruel, vicious, sadistic and uncalled for very painful action, in support of his mentor and guide, Mr. M. Kulshrestha. (Evil.) Both these doctors ignored *published medical papers and* subjected me (this patient and likely many more) to harmful treatments. Knowingly. Deliberately. Contrary to GMC directives. The GMC has *refused* to stop them giving the same irreparable damage to more patients. I can confirm in truth the *fatality* of their actions. Their treatment to inflict irreparable damage on their patients. Specifically; Awakening blindness, continuous pain, head injuries, loss of balance, blackouts. et. **Deliberately**. With overwhelming evidence; *all denied* by the GMC, whom replied with contempt for my suffering. The Police have also *refused* to *investigate* their

actions. Deliberate injuries they inflicted as crimes at all. Painful Crimes of GBH and attempted Murder.

I have notified all "interested parties" by recorded post for this review. (Please see postal receipts) Where an address is withheld I have sent it to the relevant department asking them to forward it on to the person.

Following the denial of my complaint by Mr Purt. CEO of the NHS, - based upon the lies of these doctors;
I reported them to the GMC. (letters encl.) The executive and staff of the GMC: a) denied the doctors had done anything wrong and b) argued with the victim (me) tendering various spurious excuses and denials.

I quote: "...The decision maker applied the correct test.... the (my) allegations, if proven... The medical examiner.. who? states....there was no risk in taking Lumigan at bed time... that the Lumigan drops could not cause NAION.... there is no proven link between an MRI head scan and headaches ...it is not ordered (the MRI head scan) by length... given the information available to us (?)... there is no evidence,.... aside from (my) your assertions... the doctor cannot be criticised, et. " these; are all GMC words in reply to me.

After *years* of this, I gave up, on the GMC. They *knew* what these doctors had done was 1) Contrary to their directives (formulary) and 2) *all* the medical publications, of which the GMC were *well aware*. I.e The *timing* of their Lumigan prescription. *Known* to be [their directive] *no later* than in the *evening*. Also: 2) *maximum safe time limit* for an MRI head scan was *1 hour max*. on this head scanner. By *both* the *manufacturer* of the machine and also the GMC, substantiated in their directives; distributed in well known *medical papers*. i.e. I hold the GMC to be *willing* and *complicit accomplices* of these doctors, before and after the events.

Most of their replies to me were "anonymous." Signed "Registrar" etc. with a few names, i.e. Ms. C. Binks. Since I, with *no medical training*, can find out what these doctors did "wrong," definitively, can the GMC. Their replies were delayed, usually by months. This also I believe was deliberate. i) The longer their delay I could recover, or *die!* ii) I could very easily lose heart in pursuing it. iii) The doctors would be able to claim their "3 year exemption rule." The GMC "long time" replies were clearly to their pre-determined advantage. I admit to finding the GMC a *terrible*, *useless*, *public service*. Biased, and argued, in favour of the doctors. *Useless* to a victim; *contrary* to their PR. Upon the *absolute refusal* by the GMC to accept my complaint. (Please see enclosed my last letters to the GMC.) I wrote strongly, in complete *exasperation* of their long delays and denials; with their total contempt for my serious complaint. Years wasted, contacting them.

Now: I trusted the Police would investigate my genuine, honest, provable complaint fairly with an open mind. I submitted it to the Aberystwyth Police force, for the CPS department, as I was instructed, by a helpful young lady on the telephone. Please continued to page 3.

I am not educated in medicine, legality, or any professions, but please, do credit me with the ability to know when I have been *deliberately* hurt. Hurt, blinded, in pain, to the edge of death. GBH and attempted murder. I believed, *in error*, the Police would *investigate* my genuine provable complaint fairly, with an open mind. That is, with all the evidence. Witnesses, staff nurse, radiologists (2), many published medical documents, Samples supplied, including my **sworn** statement as material witness to what these doctors had done to me. **Not so.** These Police officers used *obstruction* i.e." *lost"* all my documents; used procrastination; in delays and, refused to investigate. They Obstructed and Perverted the course of Justice. If any of them received similar treatment would they accept this? Blinded, years of head pain, by a continuous 80 minute scan; with an eye stabbing to complete their Evil? That is; irreparable damage to my body; deliberately done by consultant doctors; professionals whom I had trusted. On the refusal of these Police officers to investigate I asked the IPCC / IOPC to investigate please. They also refused; referring it back for "local" resolution! I.e. By the **same** officers who had **already** refused to investigate my complaint. A **useless** exercise; more delays. In the summer of 2018 I telephoned the CPS and asked how I should make a complaint regarding GBH and attempted murder (by proxy) by two men employed by the NHS. A young lady answered my call and told me to deliver my statement, with full details, into the local police. [Aberystwyth] Police station. I did this. I collated all the relevant information appertaining to my statement; evidence, documents, etc. in a 30+ A4 pages file; delivering it by my hand into Aberystwyth police station on 28th August. 2018. Mr David Davies, on reception, accepted my thick file and I requested a receipt off him for it please. He declined to give me a receipt, saying they do not do that.(?) In this case, I asked him to ask the CPS to acknowledge receipt of my file please. One which had taken over a month for me to write and compile. No such acknowledgement was received. Concerned I telephone Aberystwyth on 14 Sept. and PC E.Thomas [no rel.] said he had not seen the file, but gave me a "call number" of 223 for it. I phoned again on the 24th Sept. and PC I. Chapman said he had not seen nor read my file and, did not know where it was; but, the CPS were not going to pursue it.(?) I asked him who said this? He declined to tell me. PC David Davies said he had put my file in the internal mail to Carmarthen. I telephoned the CPS and a Ms Tracy said they had no knowledge of my file - which should have had a URN. [unique reference number.] I was not given a URN; and the CPS have no record of it. I contacted their complaints department who were also unable to locate my file. "Lost," all my work! Carefully sorted and typed evidence of my complaint with my statement, **published** medical documents, etc. Detailed proof of their deliberate treatment. All "Lost." All my work gone! I said, a duplicate will be supplied.

I can understand why. When the police find I write the truth (I do) it will become necessary to take action against these doctors and organisations which *notably*, the Police firmly refuse to do. And we pay for this? Their "refusal to investigate" is a breech of contract. Crown employees we are obliged to pay, in our rates. While they, like the GMC, refuse to investigate and deny my genuine valid complaint. Refusing to stop these men from hurting many others. Refusal by these Police officers - to *do their duty* - for very serious crimes. On Feb. 12th at 5 p m. Mr Rees telephoned me to say they would not be pursuing my complaint and, he did confirm this on the 12th May writing, "No crimes had been committed... no crimes would be reported."(!) These doctors, I am told, are now in Shrewsbury and Crewe; with *their* Gospel of blindness, pain and death. I ask you: is this Justice? I find it very disappointing, appalling! For over 70 years I have naively supported the Police. The first time I report a serious crime they refuse to help; and *definitely fail -* to protect the public. One can complain, suffer, and die; while they refuse Justice. I am ashamed to say these officers represent the UK law. Note: I have not made any representations to the media; the press; nor television; to bring them into disrepute; since it may easily destroy public confidence. And, help incite rioters, etc. I respect authority. Abide by it; and contribute to it! But where is it, Justice! Who is the enemy? The GMC and the Police; who allow these doctors to carry on? Or me? A law abiding, old man? These doctors knew exactly what they were doing. They knew, and would know, as consultants, who do this work every day. I.e. Expected to know that Lumigan (a perfectly correct medication) will instigate awakening blindness (NAION) if used at bedtime. Why did he prescribe it at bedtime? Contrary to the GMC directives, and, the published medical papers? I obeyed him. (He is a consultant; and knows far more medically than I ever will.) Now: this consultant orders a continuous multiple MRI head scan for me. Scans which he orders regularly, knowing this one, with his multiple scans, would need an excessive duration of 1 hour 20 minutes? (80 minutes!) A normal MRI head scan duration is ~40 minutes. Why, did he order one (for me) requiring 80 minutes? A grossly excessive. double duration, condemned by his peers and, in gross excess of the GMC directive - of 1 hour maximum! (60 min. maximum.) Regulated, as specified by the machine maker also, the GMC. His multiple MRI scan was more than enough to cause a stroke embolism or similar death. It gave severe head pain for 3+ years! Simply: **They wanted me dead.** Dr Paul stabbed into my right eye, in pretence of an E.P test. Mechanically and painfully blinding me, again! The pain lasted for months; day and night, with no let up. They abused an old man with **good** eye **s***ight*. One who *respected* them; prescribing him into blindness and "everlasting" pain.

One certain to ensure I could <u>never</u> recover this time. I did! Still blind (1 eye) but alive; asking for Justice.

These police officers have broken their contract. They enforce the law, for which we have paid, - in to the public purse included in our rates. For me this year alone, £100's of pounds. Over 60 years, many £1,000's. This yearly demand is taken from me, forming a contract which they have broken, refusing to "*do their duty*." We pay them to protect us, and enforce the law. And the law is - their own law. Only whatever they say it is! The way the police have replied to me i.e. (There is No specific intent No crimes committed .. etc.) is such: a) These police autocratically condemn my complaint as untrue. It is true! I will swear every word on oath. b) By refusing any investigation the police usurp any decision rightfully made by a judge or jury. Is this legal? i.e. The Police enforce the law, and their law is... only what they say it is! Unbelievable bias. Prejudicial. c) The actions of these doctors **embody** the proof of their intent. It is self-evident. Lumigan drops at bedtime <u>will</u> instigate awakening blind. Excessive MRI head scans <u>will</u> instigate detrimental effects, stroke, or death. By my G.P. and God's help I recovered my sight. (one eye) Survived their 80 minute MRI head scan. (Evil.) To do my best - to see **no one else, ever,** suffers their treatment. Treatment as given by these two "doctors." When the GMC and the Police deny it and refuse(!) to investigate their deliberate harm, they sow their seeds of injustice wide. The public need only to see how the GMC and Police obstruct, pervert, and refuse (!) to investigate for a victim. I need none of this; a total waste of time. Only to stop them doing their Evil to others.

My wife asked me: "Why do I not get angry?" I replied. "Anger opens the door for revenge; and while it can be swift and understandable, it will make me as Evil as the perpetrators. Also, will not deliver Justice at all."

A neighbour's dog was stealing my chickens. I telephoned the neighbour and told him. He said, "Show me!" We agreed to meet at the adjoining fence. I showed him the dog, chicken in his mouth. Another dysfunctional post, just to help the police. Not, as **promoted**, for the public. Please understand why I can confirm: "I can find No justice in the GMC, nor these Police officers."

To: Your Lord and Ladyship. Judicial appeal 6. Why do I pursue this? Page No. 6 At 82 why do I pursue this? It would be *far easier* to "cross over to the other side of the road." (Biblical.) My G. P, and God, did help me recover from the Evil of these two doctors. - In order to reveal how the GMC and Police practice. My conscience *dictates* these doctors *need* to be stopped from doing their deliberate harm to others. Lines of elderly ladies and men, awaiting their turn, to be "treated" by these men. Lost souls, whom, unknowingly, may regret ever meeting them. If these doctors had apologised, or shown any sign of helping me to recover, this would not have arose. Instead, they decided to "double down" to get rid of me. Dead. Permanently, by proxy. With a stroke, embolism or similar affect. Ideally death! Also, discredited by their lies. As dishonesty is of **no issue** at all for them, only being removed off the Registry can have any effect. Even this may not stop them; but it should remove their shields. The GMC and Police; i.e. removing their "cover." Please record: They have **demonstrated clearly to** me, they are **pre-disposed** to selected **Evil**. No apology, No contrition nor remorse. To **deliberately** make a person blind is **Evil**. And if they find out how, they **kill** them! I have good reason to believe they have done this before. They *certainly* did it to me; and, *will do it again*. Because: they can; and, get away with it. Shielded by the GMC. Protected by the Police; they are **invulnerable!** Without doubt, they are extremely clever educated men; who c/should do a lot of good. Credit due. I feel sorry for them - as doctors they are truly mentally ill. I wish them no harm, as they disqualify themselves. Justice? This is not for me to say. The denials of the GMC and the Police show a more worrying picture. Think of the effect this has had on me. A normal, law abiding, family man whom pays his taxes, even his TV licence, insurers his car, and in every way supports authority for the good of the community. And now see corruption in the GMC and Police. We call on the police to support us against crime and now, they positively refuse to do so? These police replies of refusal sow their seeds; note: by these officers, for riots etc; requiring additional policemen, body armour and weapons, et. At huge expense, and with injuries! To control what these officers have originated themselves! Because: Justice needs to be done; and seen to be done. Not denied, lied about, and refused! Every complaint handled incorrectly can become a fuse. The police need to build integrity which takes time. Every complaint handled with the care shown to me, irretrievably breaks police support. (just in case.) Call me paranoid; but consider; I have had to write this letter and trouble you.

Why cannot I "let it go"? Because: these doctors <u>ruin peoples</u> <u>lives</u>. My income was a fraction when blinded by these doctors. I also could not fulfil my family, for years. My wife had cancer; and my children problems. The damage by these doctors presented difficulties for me, and my whole family. They should not do this. I do not need to reiterate it all again, it is in my letters to the GMC and Police attached. All painful memories. You may understand if you put a blindfold on - not to see the blue sky, cotton wool clouds, a green lawn, the flowers, or my wife/children. All this; plus the years of pain, and denial, by the NHS GMC and Police! *Evil*. I cannot think of *anything* more evil, except torture, than to make anyone *deliberately* blind. Try it sometime! Also he refused to help me, saying I must stay this way, refusing his help. This *consultant* whom blinded me. And if you speak up - he tries to kill you! Note - I write not from maybe's but provable facts. Denied by all. Professor S Hayreh - whom also gave the **remedy** for NAION [awakening blindness] Prednisolome, taken in 14 days had a 75% success cure rate. I showed these papers to the consultant and he rubbish-ed them. I asked for *anything* to cure me, please? He refused to discuss it, and refused to prescribe Prednisolome. My G.P. kindly gave it to me, and my sight recovered almost completely, within days! The consultant became extremely angry(?) He recommended an MRI head scan saying it was perfectly safe, like an X-ray. I attended his scan - which ran for 80 minutes by the wall clock. I could not rise off the table! The radiologist assisted me and I asked her "why did it take so long?" She replied, "It was multiple scans as ordered by the Consultant and I would have to ask him." His assistant Dr. R. Paul meanwhile also did an eye pressure test using local anaesthetic he stabbed into my right eye. When the anaesthetic wore off the pain was extreme. The MRI head pain lasted over *3 years*! Lost balance, black-outs in the street and, my eye never recovered. I complained to the NHS - whom believed the lies of these doctors. I reported it to the GMC - whom found no fault with the doctors. Then I reported it to the Police 3 years ago, and they refused to investigate my claim. Only deny it ever happened. "No crimes committed.." Nothing has been done, to stop them doing it again. Now an 82 year old pensioner, I cope, like most, to pay my way. I cannot afford expensive solicitors - whom decline to act for me; as to be "futile" against the police and doctors. But I have survived their mal-practices. About money: I am willing to pay, from what little money I have, to bring this review to court to stop them if possible. No more patients should suffer as I did. This is how serious I am - to prevent these doctors hurting others in the same way. They blinded me, gave a grossly excessive MRI head scan, and stabbed my eye. May I ask the court please, that we each pay our own costs; as I am unable to pay their costs from my state pension. I have budgeted for court fees, hopefully to be up to approx. £1000, with no solicitors. These are your "dogs" who have lost me the last 8 years in blindness pain and suffering. Please stop them.

I believed (hoped) these last years of my life would be peaceful, at home, playing with my "colouring" book. What I call my computer; after my childhood, when I was ill with measles, etc. my mother would bring me.

Note: Both these doctors acted *deliberately, knowingly, fully aware,* of the *Evil* in their treatments. Their treatments were *not* accidental, *not* negligent, simply and expressly *deliberate!* Without any doubt.

I am a truthful factual material witness. Reporting how I have been refused, by *repressive* organisations, whom have *all denied* my statements these past few years. With no thought for me or others. I claim:

These were; and always will be, truly appalling *crimes* for *any* victim. Regardless of the perpetrator's status. I.e. I ask you to agree: From near perfect eyesight - to make anyone blind deliberately *is* a crime, whoever does it. To "cook" anyone's head in an MRI scanner for 80 minutes *is* a crime; also *stabbing* into my eye.

I ask: please would you review my case for the benefit of others, who will receive *the same* treatment that I suffered. GBH and attempted Murder. What you do with these doctors is not for me to say. Not my concern.

Truthfully, these are your "dogs" and I ask you to treat them accordingly. The GMC and Police have **refused to investigate** what these doctors did. Ignoring the witnesses, **conclusive** medical evidence, facts, my sworn statement etc. i.e. **Not one of these officers**, including the **IPCC** or **IOPC** would investigate my complaint!

I can still see (only with one eye) the unbearable head pain has rescinded after eight years and, I manage. Every organisation and person has rejected my complaint. All investigation refused. No one wants to believe my story, no matter how true. If you also reject me, does it really amount to a "hill of beans"? I will die soon; the doctors will carry on with their "Jekyll & Hyde" practice until, hopefully, some one else can spot what they have been doing, for years. The GMC and the Police will go through their routine of denials; the only persons hurt are those they abuse? Over time this may be hundreds! Also, they are tutoring the new young doctors into their doctrine. So it will multiply. This is corrosive; overall corrupting. This "watch my back and I will watch yours" philosophy is bad. The rogue professional, in any profession, corrupt their larger team. A rotten apple in the barrel syndrome.

I now see this affects **all** the professional walks of life; even the Police. It has spread too far for public good. Deliberate mistakes and errors proliferate; good people are compromised; and inevitably, a "barrel becomes rotten" **Every** serious error by **anyone** should be transparent; reported to ensure the good intent of the team. Integrity if you will, so the **whole team** is good and, weeding out corruption. Whatever profession is involved.

I have been very disappointed (appalled) by the responses to my complaint. Denied by authority. A Cover-up. It is not my concern what happens with these doctors. (No Duty of Care) These doctors know this. (in their hearts; and why they tried to kill me.) The GMC know this; they ignore me *deliberately*. Ignoring *their own* GMC directives. The police know this; *refusing* to investigate, to grasp the nettle; these most serious crimes.

For **60 years** I have supported the Police; paid £1,000's of pounds in rates tax, *for the police*. And the *first time* I inform them of this *most serious* of *crimes*, GBH and attempted Murder they *refuse* to help: everyone!

May I ask you, not for myself, but for all those elderly persons (I have seen) whom innocently wait for hours and can be prey, like me, in their hands. *Please* do not fail them. I respected the knowledge and expertise of these doctors and they made me blind! Then tried to murder me! I found out what they did and knew to much.

If I embarrass you - I am sorry. If you condone what they did, you fail to see justice prevail and collaborate. Please would you acknowledge my letter. Thank you for your time, your Lord and Ladyship. Yours most sincerely,
