I report: these doctors used their knowledge and equipment to **deliberately** harm me. A patient. Evil. They *laugh* at Justice. Shielded by the GMC; with their lies as necessary. Protected from prosecution, by these Police officers; who **refused** to investigate all the evidence, witnesses, medical documents, etc. And seek **any** and all excuse to deny GBH and attempt Murder. They did obstruct, pervert, and **refuse** Justice.

These doctors **knew** what they did to me. Not by accident nor negligently. Knowingly aware, **deliberately**. Their GBH & att. Murder are serious indictable offences. An eye stab and heinous 80 min MRI head scan. They made - and left me, blind. In continuous pain, refusing any help. Knowingly, and deliberately. Evil. The GMC **knew** their mal-practice was contrary to their directives; and lied, to deny my complaint. They to are **indictable** - for allowing these doctor's licence; to further endanger more victims, to suffer by their Evil.

These Police officers, with whom I pleaded "not to go down with the ship. Please, to do their job, and not be mislead by them; nor the GMC" - whom rightfully, should have stopped them. These Dyfed-Powys Police officers **knew** there was a **criminal** case to answer here and - covered it up. They obstructed and perverted Justice. Autocratically **refused** to investigate; and allowed these two men to pursue their mal-practice. These Police officers for their obstruction and perverting Justice are also **indictable**. They are complicit, after the fact. We can **never** stop the errant persons while these Police refuse to do their job.

All my life I have, naively, believed and supported the Police. Paid thousands of pounds via the rates in full support. Believed their PR, as expressed on television. Now when I call upon them to **investigate** these serious crimes of GBH and attempted murder enacted upon me; these Police officers **refused**. To investigate their crimes? Worse: they **deny** they have committed **any** crime! To call the *victim* (me) a liar!

I swear to God, on oath, every word I write, **is true**. The truth, the whole truth, and nothing but the truth. So help me God. But all these words, the witnesses, the evidence, the medical publications, my honest factual statements, and all my letters about the blindness, pain and suffering by mal-treatment, given to me, **deliberately**, by these two doctors, meant **absolutely nothing** - to these officers of the GMC and the Dyfed-Powis Police force. Their "law" is simply **"what these police officers say it is!** They expose: A cosy, corrupt network of denial to victims; to their own criteria. Disregarding the issues to allow crimes. The IPCC said: "for local resolution." If this was a euphuism for Justice, I can find no evidence of it. These men, I am told, are still employed by the NHS, giving patients the benefit of their own brand of medicine.

For these doctors; the GMC executive, examiner, and staff, have **proved** they are willing to **lie**. **Contrary** to their **own** directives. And, the Dyfed-Powys Police officers compound their failure to protect the public. By openly **refusing** to protect us, with no investigation. Their firm, clear, refusal to protect the public is a dereliction of duty; inconsistent with their role in office. Not ONE of these officers could confirm my report.

May I refer you to my last (page) letter to Mr Goddard, the Police legal dept., who intercepted my mail and dismissed my appeal, for a Judicial review. The police final act of obstruction and perversion of Justice. In this I have done my best to save others. I have **played my part** for the last **8 years**, and all to no avail. Now, 82, I shall not be around much longer and, can do no more. All **responsibility** for the blindness and suffering, deliberately caused by these two doctors, is totally now the product of these police officers.

I did not ask for their punishment; nor imprisonment; nor fines. Only for the Police to simply prove to their own satisfaction in conclusive evidence by investigation, what they did to me; and then remove them from the medical register, so they could not hurt others in the same way. Refused. **Obstruction** from day one. Therefore, all crimes they now commit by their mal-practice are: the **sole responsibility** of these officers.

I can legally do no more. Solicitors advised me I have "**no chance**" with these doctors nor the Police. If I **could** obtain their investigation, then the CPS would take-over the case, to nullify it. There is: **No Justice**.

This Police (and GMC) **refusal** to investigate serious crimes is truly appalling. A contempt for Justice - by their refusal, could instigate street riots, damage and injuries. Lots of expense for.. what? Disillusionment? When the Police cannot be trusted; when they refuse to investigate crimes; to whom can anyone apply? These policemen chose: "what **their** law is." Whom have committed any crime; and laugh at their victims! With obstruction perversion & **refused** investigation. To report a serious crime to these Police is pointless!

I promise: I will **not** write **nor** trouble you again. In the thought you may be able to correct this **appalling** state of affairs. One that **regularly** repeat itself. Dr. Shipman, Stafford hospital, many covered-up doctors. Yours most sincerely, Jerome Thomas.
