Dear Mr D. Llewelyn, Sir,

Dear Ms. Nicola Harris,

Thank you for your long detailed letter of explanation of 5th June in reply to my request to the Commissioner. I ask:

1. Please would you confirm that Mr Llewelyn himself, has actually read the letter I sent to him please. A copy is attached if you are unable to find the original.

2. I have some difficulty in discriminating between "appeal" and "review." I believe to have tried already, all the "appeals" which have been all referred back, - to the very same persons - whom *refused* to *investigate* my complaint in the first instance. Now, two years later, remains only a "Judicial review." Before proceeding in this action, I feel it is fair and appropriate on my part, to give the police officers concerned a chance to reconsider.

I doubt, very much, Mr Llewelyn *could* convince them but, at least they will have had *the chance* to do so before needing to explain their decision to the judges. (Lord & Ladyships.) So avoiding any difficulties being created.

In reference to your legitimacy of the commissioner's role, may I quote " ... I will give a voice to the public, especially *victims of crime* and work with other services to ensure the safety of the community and effective criminal justice. I will take *all steps* within my power to ensure transparency of my decisions, so that I may be properly held to account by the public..." (In fact, Police and crime commissioners are *also responsible* for the appointment, suspension and dismissal of the Chief Constable.) I ask, only as a member of the public, would he please ask the Chief Constable to re-consider his refusal to investigate these crimes enacted upon me? To not become involved in operational policing. Just advise him; no investigation of these crimes, *is a crime* itself.

I do hope you can follow my reasoning in this, and pass on my letter please to Mr D. Llewelyn, for the good of everyone concerned in my case. Please believe me, I have no wish at all to fall out with the police, but truly feel they *should*, and have an obligation to, investigate the GBH and attempted murder enacted upon me.

This, my request of the commissioner to ask him, is reasonable, justifiable, and fair.

Please thank him for his time, and let me know in due course. Thank you.

*DECLINED TO
APPEAL TO THE POLICE*

Dear Mr D. Llewelyn, Sir,

I am very disappointed in how the Dyfed Powis Police have responded to my complaint of attempted murder and grievous bodily harm. May I ask you Mr Llewelyn, as commissioner, to please contact the chief constable Mr Mark Collins and his senior officers in this regard. Following the advice for me seek a judicial review, I ask this of you; I will not write to the Police anymore; it is pointless. Nearly 2 years from my original complaint.

My case is quite straightforward. If you can agree:

To make anyone blind, deliberately. Should this be considered a crime? These police say: No.

To stab anyone in their eye, putting them in excruciating pain and permanently blind. Should this be considered a crime? These police say: No.

To prescribe for anyone, a continuous MRI head scan of 80 minutes duration. One *excessively* long and very likely to cause a stroke, embolism or death. Should this also be considered a crime? These police say: No.

If you can answer yes, to any of these actions, I ask Sir, would you please contact the Chief Constable (Mr Mark Collins) and his senior officers (named below) of the Dyfed-Powys Police force, to reconsider their decision. Their reply in writing was: Quote: "**No crimes of specific intent have been committed that would require police investigation, and therefore no crimes should be recorded.**" A ridiculous statement. (IMO)

Briefly: I write in reference to the GBH and attempted murder of myself by the attached named two doctors in Aberystwyth Eye Clinic. While admittedly the licensing of these doctors, I believe, is the prerogative of the General Medical Council. (GMC) The GMC deny their actions were unprofessional, even when contrary to their own rules! (directives) And, have allowed them to continue their medical practice with no regard for public safety. The GMC are biased for doctors, not for their victims. But, the GMC may not come under your remit.

However, Dyfed police do. The police have refused to make *any* investigation in reference to my genuine and verifiable claim of their attempted murder and grievous bodily harm, committed by these two doctors upon me. Dyfed-Powis Police have, repeatedly, refused to consider my claim seriously. Submitted on 28 August 2018.

Effectively these two doctors have "gotten away" with blinding me (NAION) and caused years of head and eye pain. Deliberately; destructively; illegally; and immorally. I sum-up in a word: Evil. They are capable; expert even; in their demonstrated "Jeckel and Hyde" services and, are dishonest. Selectively, harming persons without a mark. The Police deny it; refusing to believe me. My statements are true. I swear to God. I explain:

Dear Mr D. Llewelyn, Sir,

If you can agree:

To make anyone purposely blind, knowingly and deliberately, *is a crime*. (GBH.)

To stab anyone, in the eye, to cause excruciating pain and persistent blindness, *is a crime*. (GBH.)

To subject anyone, to a grossly excessive continuous MRI head scan for 80 minutes, causing years of pain, loss of balance, black-outs and probable stroke embolism or death, *is a crime?* (attempted murder, by proxy)

Then may I respectfully ask you to guide these police officers (named below) to agree my claims of attempted murder and GBH *should* be registered - as crimes. In total three crimes against my person; and, to be pursued therefore accordingly. That is, as commissioner, please can you advise these police officers to pursue the case by acknowledging that the treatments these two doctors prescribed for me - were crimes. Crimes for which they should, and rightfully be called, to answer.

According to Mr E. Burke: "All it takes for evil to succeed is for a few good men to do nothing."

Please consider: would you like to trust *your* relatives, family members, or yourself, to these two doctors?

The NHS (Mr Purt CEO) denied my claim; based upon the lies of these two doctors and, fearing liability costs. The GMC denied my letters of complaint repeatedly; blustered them through in prejudicial contempt, on behalf of these doctors for two years; even though they had ignored the GMC formulary. (directives) And now, Dyfed-Powys police also have refused to investigate their actions saying: "...NO crime has been committed... etc.(!)" As the Commissioner, Sir, I write to ask you, at this eleventh hour, can you please guide the police to come to a just and correct decision please? I explained to them:

The way the police have replied to me (no crimes.. etc.) is such:

- a) The police are *autocratically* condemning my complaint as untrue. My complaint is true. I swear it on oath.
- b) Without any investigation, the police *usurp* a decision to be *rightfully* made by a judge or jury. Is this legal?
i.e. The Police enforce the law, and the law is... **what they say it is!** Unbelievable bias. Prejudicial.
- c) The actions of these doctors embody the proof of their intent. It is *self-evident*. Lumigan drops at bedtime *will* instigate going blind. Excessive MRI head scans *will* instigate detrimental effects, a stroke, or death.

My background: I was healthy hard working and industrious. Born in 1939, I grew up on my own, parents at work, including night shifts. I worked to get pocket money and at 11 I bought a Diana air pistol, shooting at targets by the outhouse wall. At 14 I bought a BSA mark 5 air rifle and my uncle, an aeroplane rear gunner in the war, taught me how to shoot - at match sticks! Wedged up in fence posts, quite a long distance away. In the air force (late teens) I could put 5 rounds, of 303, into an old penny circle; in fact so accurately they said I had "put some over the top." All with no telescopic sights. Later, I had a private pilot's licence to fly.

This is to show *how good* were my eyes. At age 73, the optician said he had to legally refer me to the clinic because my eye pressure was 22; even though I could read down to the bottom line of the eye chart, with each eye. On attending, I said to the Consultant "my eyes are fine, thank you." He said No! If I did not use the Lumigan drops I would suffer Glaucoma - and he could not correct this. I did not have Glaucoma, only *his risk* of it, - *if*, I did not do as he prescribed. "One drop in each eye at bedtime." Which I did, I duly followed his prescription. On 29th October, after only a few weeks of doing this, I awoke - completely blind.! Panic. I rang my G.P who made an immediate appointment at the clinic. After an examination the consultant said I had NAION; and, I would stay that way, blind. This could happen to anyone, anytime. (Not true, it was his miss timed Lumigan.) He, and his assistant, knew the truth. His prescription had been deliberately miss timed.

With copious over the counter medications, I recovered some sight in one eye myself, and researched online. I found medical publications which not only explained the result of his miss-timing - blindness, but also how to cure the blindness he had caused! I showed him the papers and, he rubbish-ed them, saying there are lots of papers. Worse, he refused to let me have the recommended medication. Although they were by a Professor of eye care; a specialist, with a 75% success cure rate. He refused again. He offered me no help *at all*. Why?

The GMC directive (formulary) advises this "Lumigan eye drops application" (a perfectly correct medication) should be used *NO later* than in the evening. (otherwise it *will* cause NAION.) Further: This very experienced consultant doctor and assistant, both with expert medical knowledge and well trained, prescribe Lumigan *daily* to their patients. i.e. They would have known this fact, and as consultant, could be expected to know this fact, as part of their job. i.e. This erroneous "bedtime" timing of his prescription at each examination, was clearly deliberate. I returned to him, blind. He said there was nothing wrong with Lumigan; and there was *nothing* he could do to help me. This could happen to anyone any time. Go home (again) blind. This *consultant* refused to help me recover my sight, *in anyway* at all! I now believe it was because.. he wanted me this way, - blind !

I submitted 30 A4 documents substantiating my complaint to the police on the 28 August 2018. Contents: Published medical papers by Professor S Hayreh (eye specialist, and many more doctors) who *did* confirm this consultant doctor had erroneously prescribed Lumigan eye drops (a perfectly correct medication) one in each eye to be used at **bedtime**; as a fatally miss-timed prescription which, inevitably, would cause "awakening blindness" NAION, and it did. This miss-timing was known by him, and could be expected to be known by him, as a consultant doctor; so why did he prescribe it? Deliberately. He wanted me his way, blind. When I showed him the papers confirming the error of his prescription (which I thought at that time, to be accidental) he said he wanted an MRI head scan, suggesting there may be something "wrong" at the back of my eyes? Still trusting him I attended his scan. By the clock on the wall it lasted **80** minutes. At the end, the radiologists needed to lift me off the table; and, unable to stand, I had to rest for a while. While waiting, I asked, why the MRI scan had taken so long? The radiologist replied " It was multiple scans ordered by the consultant and, you will have to ask him why." Within the hour the head pain started. A steel band around my head which felt like bursting. The worst headache I ever had in my entire life! It lasted continuously for 3 years! Night and day.

I found out: a normal MRI head scan takes approx. ~40 minutes. The *maximum* scan safe time allowed by the GMC and, the equipment manufacturer, is **60** minutes. The multiple scans, *he ordered*, required at least **80 minutes!** - Double the normal time! Why? I had shown him I knew too much; and he wanted me.. dead. His *grossly excessive* continuous MRI head scan, *double* the normal time, was a surreptitious attempt to murder me! (to cause a stroke, embolism, or death.) Put upon an old man, who had had no medical problems.

Meanwhile his assistant doctor (Dr Paul) said he needed to take an eye pressure test. This he had done several times before at each examination. He put anaesthetic in both my eyes, my head on the cradle, put an attachment on the machine, and - stabbed sharply into my right eye! He arose from his chair and, taking his attachment off the machine, placed it into his left hand jacket pocket, and left the room. All this in less than one minute! Not a word said; no notes made. A very fast and efficient, "attack" on my eye. When the anaesthetic wore off, the pain was... unbearable. Night and day, without end; for three and more months. It is still blind, and sore, to this day! 7 years later! For me, it is a *daily reminder*; to pursue these doctors, for the safety of others. Deliberate *crimes* against my person. By consultant doctors whom have lied about it ever since. Evil.

I reported it to the NHS and - these doctors said: I was a druggie, had demanded medications, had missed several appointments, etc. *ALL* lies! I have never, in my life, taken illegal drugs. Never demanded medications (I appreciate doctors have a responsibility for drugs) and, have not missed any un-cancelled appointments etc. All this is *libel*, to have me removed off their list, i.e. to get rid of me. I ask: why would a consultant of any merit have the need to lie and discredit their patient? Only one who knew the patient could expose his deliberate mal-practice. Simply. I knew too much. These doctors *should* be held accountable. I am certain, if they did this to *any* of the police officers, they would say, without any doubt what so ever, what they did.. *was a crime*.

Neither the GMC nor the Police will accept this. These doctors showed a *clear pre-disposition* to harm me. First, I thought making me blind was an accidental mistake. However, because I showed them how, I knew too much and, they determined to get rid of me. His MRI scan and the eye stabbing was positively deliberate. To cause a stroke or death to hide their mal-treatments. This final treatment, from which I was never supposed to recover, was attempted murder. (by proxy.) It has taken me years, by myself, to repair what they did to me. Why they did it, I do not know. Experiment? Dislike? For whatever reason, it was wrong to do it. As doctors, they are mentally ill. As a patient; I showed them respect; they abused me. I trusted them; they tried to kill me!

They knew they could get away with it. No patient, *ever*, would suspect or find out about their false Lumigan prescription. And, if they did find out, they had a "fall-back" position. Double down - and kill them! (by proxy) By causing a stroke or embolism using an excessive MRI head scan. If questioned, all can be easily justified.

My mistake was to *tell them*, in trust, what I had found out online about the Lumigan. (many of these papers have now been removed but can still be found online) Also the clock and, I believe, even the MRI machine, have been replaced; so "removing" all evidence. However there are witnesses and every word I have written, I swear to God, is true. Unacceptable treatment from doctors I trusted. To cause blindness pain stroke or death.

Before applying for a judicial review, as advised, please would you, Mr Llewelyn, convince the police on my behalf, to make the right decision? i.e. These were, are, and always will be, crimes against the person.

These doctors should be brought to account for their actions please; 1. to prevent them doing it to others. 2. for almost ruining my life. (blind and in pain) 3. for causing me to deny my wife (cancer) & children the help they needed. I thank you for your time.

The charges (as submitted):

Mr M. Kulshrestha: consultant: Charge: Attempted murder (by proxy.) Grossly excessive MRI head scan. or **GBH** - as the scans caused 3 years of pain, and were crimes - to cause a stroke or embolism. (for death)

Dr R. O. Paul: Charge: Grievous Bodily Harm (GBH) For his stab in my eye.(still blind) Pretence of E.P. test.

The GMC executive and staff: Complicit Accessories. (registrar, assist. registrar, examiner, staff. etc.) Most replied anonymously in discrediting manner. Hopelessly defend these doctors; and allowed them to continue.

The Police - Mr J. Rees, Mr S. Davies, Mr S. Reynolds, Mr G. Lemon, Mr H. Davies, Mr Murray, IPCC, etc. Obstructing & Perverting Justice. (possibly on direction from: Mr Mark Collins Chief Constable or Ms. Claire Parameter. Deputy Chief Constable, or others, unknown.)

I entered my complaint by hand to Aberystwyth Police Station on the 28 August 2018. The desk man refused to give me a receipt at the time, saying they do not give receipts. So, I asked him to ensure this important file reached the Chief Constable and the CPS please. He said he would.

I checked this had been done a fortnight, and then a month, later. They said they had "mislaid" the file admitted it was lost, and, they had no idea where it was! I said I would supply a duplicate, as best as I could. I did.

On the 12th February 2019 Mr J Rees telephoned me to say they would not be pursuing my complaint, as too many people were involved. (or words to that effect, as I understood.) I said these doctors had acted to cause me GBH deliberately, and attempted murder. He wrote, "The police would not investigate my complaint..."

I submit: This was **obstruction** and procrastination, with *never* any intention, to investigate my complaint.

In May of 2019 Mr Rees confirmed this in writing, stating, as I have put in my letter "No crimes committed.. etc" and therefore the Police would not be investigating my claim. I complained to the IPCC - whom stated this was to be for local resolution only. i.e. They sent my complaint back, to the very same officers whom had refused it originally. A dead end of a merry go round, in police help. Pointless, unless they wanted me to quit!

I submit: this was **Perverting** the course of justice. How *can* the police *justify* NOT investigating a complaint of attempted murder and GBH? This is why I have asked you to help please, as Commissioner. If you are unable to get police officers to see how serious is my complaint; thank you for trying. I will revert to a judicial review. Every day I have a permanent reminder in a blind, sore eye and a damaged head. With black-outs, loss of balance, and collapsing, some times in the street, thanks to the "skilful treatment" of these two doctors! Killers. You can tell them: I refuse to give in. I can still see (one eye) and, I survived their excessive head scan. For my wife and children, the sky, flowers, etc. With no apology, contrition or remorse from them I will always hold them responsible for my condition. And ask: is it right, for the police to refuse to investigate attempted murder?
