Dear Mr Mark Collins QPM. Sir,

Please thank your Staff Officer, Ms Tanya Grey, for her letter confirming my content is being "addressed". I trust and enquire if you have made progress please? It will be 2 years in August since my original complaint was submitted to the local police, as advised, by the CPS. The police intention was stated, verbally and written, to obstruct and pervert justice. Do the police pay no regard to my serious and genuine complaint?

Please accept I do not complain easily. In the early 1960's a heavy switchboard off-loading a lorry fell onto my foot. Very painful. I hopped to a nearby hospital for an X-ray. The doctor said it was badly bruised but would recover. I hopped to a bus home in considerable pain. The next day a card came in the post saying, "report back to the hospital, you have a broken foot!" Which I did. Now needing a plaster cast for far longer. The point being this was *not deliberate* and, they tried to correct it with their postcard. Yes, negligent; I did not complain. Several months after our first child in 1971 my wife was still bleeding. Attending at the hospital the doctor, without proper examination, gave her a scrape. An *enforced abortion* ensued, with considerable damage and tremendous loss of blood. The day later, on my visit she was a "little white doll" in the hospital bed. Painfully ill. Negligent yes, but not deliberate - and they corrected it (saving her life) immediately. I did not complain.

This case is <u>deliberate</u>; were this consultant doctor erroneously prescribed for my use Lumigan eye drops, one for each eye, to be instilled at bedtime. This was a prescription, repeated at each visit, for *bedtime* use. This bedtime use is well published medically to *cause* awakening blindness. (NAION) He <u>knew</u> this fact and, could be expected to know it, as a consultant and part of the GMC directive. True to form on 29th Oct. I awoke blind. A *devastating* experience. More so because my eyesight was perfect for my age. Reading to the bottom line of the eye charts etc. My work, play, and care of my wife & family all suffered - due to this consultant's actions.

Returning to the eye clinic immediately, the doctors said they could do *nothing* for me; nothing at all, go, blind. Why did this consultant refuse all help? Because he wanted me blind. He knew, from the start, how to do it. With help, obtaining medication from my GP, based upon the well known medical papers, many created by a professor's life time dedication to eye care. (all supplied) I naively returned to the clinic to advise them how they could help others, blind, in similar distress. My mistake. These doctors *knew it all*, *already!* With hindsight, prescribing every day, they *would* know! Worried now, of me exposing how they had prescribed for me, he arranged a MRI head scan. A perfectly safe (he said) head scan. I found out, later; a normal MRI head scan is approximately ~40 minutes long. The *maximum* SAFE time allowed, by the GMC, and manufacturer was 60 minutes duration. He ordered multiple scans to take 80 minutes in duration. A grossly excessive scan. Double the normal scan; one almost certain to cause brain damage, stroke or death. I could not stand up after this treatment. My head ached for 3 years continuously night and day. My loss of balance caused me to fall over in the roadways etc. - but I did not die, as he had planned. Saved by the Grace of God, to expose him.

All by a consultant and his assistant who <u>knew</u> what they were doing; and, was contrary to the GMC directive. His assistant "stabbed" my eye viciously; using a pretence of taking an eye pressure reading. To make certain I would *never* be able to correct this action, by medication. Never to see, with good eyesight, ever again. Evil.

With these two doctors, it was <u>deliberate</u>. As consultant doctors they can be <u>expected</u> to know, and they did know, what they were doing. Additionally; they made <u>no attempt to correct</u> my blindness. When I naively tried to show them what they had done wrong (prescribed Lumigan eye drops at <u>bedtime</u>) and, how they c/should correct it. They tried to hide it all, <u>with murder</u>. An <u>excessively</u> prolonged MRI head scan. Both these actions were <u>clearly deliberate</u>. I reported them. I reported them to the hospital, whom, believing the doctor's lies, denied me. I reported them to the the GMC. (for years; asking them, rightly, to stop these doctors.) The GMC, **denied** all my letters, reports and medical papers submitted as proof, with contempt. I asked them to remove the doctors <u>quietly</u> for their <u>damage and lies</u> they told. These doctors had <u>disqualified themselves</u>. The GMC refused to stop them, or remove them off the registry. Rightfully, the GMC were the <u>correct people</u> to stop them. The GMC refused, several times. Causing me to turn to the police to stop them. For the public good.

Hence my charge. The GMC were and are, by allowing them to continue, *complicit accomplices* to the actions of these two doctors. If the GMC executive had done their job, the police need never to have been involved. Now we come to the police. Soon, nearly *two years* will have past. (in August.) The police have:

- 1. Refused to give a receipt for my file, 30 A4 pages accurately and honestly detailing what these doctors did.
- 2. "Lost" all these (my) papers, which took me a considerable time to write and collate, near blind and in pain.
- 3. Phoned me to say "they would not pursue my complaint as "too many people are involved." (words to effect)
- 4. And now you all state: "No crimes of specific intent have been committed that would require police investigation and therefore no crimes should be recorded." (!) This in regard to my claim of GBH and attempted murder! This police denial is made such as this has never happened! Well it did; and the public are at risk. I explained: Their intent is self evident in their illegal actions. To cause blindness and death by proxy. Their "intent" requires no investigation. Intent is embodied in what they have done. Ask any consultant to confirm: Lumigan at Bedtime will cause blindness.(NAION) Excessive MRI head scan will cause stroke/death. These consultant doctors knew this. i.e. Their treatment was deliberate. Their actions had self-evident intent. Further: I did not consent to this errant, medical treatment; believing it would be by a "normal" caring doctor.

Your *police obstruction* and *perverting justice* is unjustifiable. My wife says "why do I not get angry?" I reply " anger clouds the mind and opens a door for revenge." I depend solely on convincing people of the truth of it. Leaving this would make *me*, also, an accessory, just like the GMC exec.. They *know*, in their hearts, as do I, these doctors, are *selectively* harming persons for reasons known only by them. At the clinic I sat talking in the corridor to a small very elderly lady, partially blind, who had been waiting *for hours* to see them; for *far longer* than me. My heart went out to her. How could I converse on her outcome? Knowing, as I did. They continue.

Can you see my dilemma? I am *conscience obliged* to pursue this. As much as I may *prefer* to stop. It's far far easier to "cross over to the other side of the road" than it is to fight for truth. The police support these doctors.

Prestigiously dressed in smart uniforms they stand proud to protect, yet, allow these doctors to continue? I believed this was cleared 700 years ago. "Magna Carta limited the powers of the king. The Bill of rights. Thus, no matter what the barons' aims, Magna Carta established *forever* a timeless idea - the idea that government, whether royal or otherwise, is limited by the written law of the land." Not so today; the police write their own laws, to protect whom so ever they please.

It seems the police *do not want* to stop them from hurting others. The GMC refuse to; now the police *refuse* to *investigate* their *attempted murder*. (by proxy) Because, they realise what it entails - when they find I write the truth. I blame the GMC entirely for not doing their job. *Every month* the media expose an errant doctor as "being doing it for years." Why? - Because the GMC refused to stop them earlier.
