Dear Mr G. Lemon, Sir,

First let me wish you a happy New Year. I am sorry for presenting my complaint at "your door" in regard to these two doctors. I was instructed to do so by the CPS stating: "take it in to the local police station" and, it has failed, after a year, to register with the police from there on. Please would you accept this second chance to re-consider your decision. These two doctors had a "second chance" and, they tried to murder me. I asked the NHS to re-consider, they rebuffed it, believing the lies of their employees. The GMC, although what these doctors had done was contrary to their directive, denied and refused my similar offer, repeatedly, frustratingly. I offer now, to the police, the same second chance and urge you, please, to accept it. Understanding: it is not what I want, but what is right for the public. These doctors tried to murder me; preposterous as it may sound.

It is a very long road which has no turning, and we work with what we have. I do not wish for the police, whom I have always supported, to fall into the "pit" these doctors have made for themselves. While they may believe they are "shielded" by these organisations, including the police it appears; I believe in honesty and justice, without end; because good should and must prevail over evil, however long it takes and detractors it may find. That said, the police do have a hard difficult job. Therefore I offer you this second chance to re-consider and revise your decision before proceeding further.

Below is my reply to your statement: "**No crimes of specific intent have been committed that would require police investigation and therefore no crimes should be recorded.**" Convenient "catch all" as this statement may be I have to disagree, for the public good. Please understand me Sir. I was (felt) "spared" from their actions - in order to reveal what these doctors actually did. If they, or indeed anyone, made you blind and *attempted to murder* you, with the knowledge and tools of their trade; I am **certain**, you also, could find fault with their actions. I ask you at this late time: Please would you re-consider carefully your reply. I explain:

1. By refusing to investigate these crimes, what *factual* verification **is there**, to say "no crime"? An oxymoron.
2. By your statement and no investigation, **you** autocratically condemn my complaint as being false. **It is true.**
3. By not investigating these **crimes** you rely **solely** on hearsay; from the same persons whom are the subject of my complaint. Prejudicial. You rely on their **opinions** only. (they feed your denial.) Opinions from a biased group of persons with contrary interest. i.e **Not factual**, simply their supportive opinions.
4. By making your declaration (of no crimes committed) the police **usurp** any decision rightfully made by a judge or jury. **Your** decision, admitted little-to-none *unbiased* investigation, maybe incorrect. Is this legal?

5. Their "**intent**" needs *no investigation*. Intent is **embodied** in what they have done. Ask any consultant to confirm: Lumigan at *Bedtime* will cause blindness. *Excessive* MRI head scan *will* cause a stroke/embolism. These consultant doctors **knew** this. i.e It was **deliberate**. Their actions were of **self evident intent**.

Also: **police obstruction** ("lost" documents) **procrastination** (over a year since my complaint) and, **perverting justice**. (police officers stating my complaint "**will not**" be pursued.) I despair in your logic; travesty of Justice. This is *only* a "case file" to you. For me it is **my life, deliberately** damaged. I will *not* let them do this to others.

The police can make a far more *correct* assessment in **days**; much less than a **year**. Ask random consultant eye doctors, of equal rank or higher these **two** questions. (note: *anonymously* please for a true response) Please ask several qualified consultants: (*not informed about, nor associated with, this case.*) **two** questions:

1. would **they** prescribe Lumigan eye drops to be used at **bedtime**? (contrary to GMC directive.) **Yes or No.?**
2. would **they** prescribe for patients multiple MRI **head** scans of **80** minutes continuous duration? **Yes or No.?**

Judgement by peers is standard. When they say: "**no, they would not.**" You have your *true* answer. No need for an **intent** investigation; - because the **result** of *their actions* are *well known* and *documented*. - Blindness and embolism ensue. (stroke or death) This is clear to doctors, and definitively so, to the two subject doctors. Respectfully, *your* summarily dismissal of my complaint enables you, for the police, to mock justice Sir.

They made me **totally blind** at one point and, in head pain for three years, after their "head scan." My one eye has recovered, the other (stabbed) is still sore (blind) My head pain rescinded. (but balance is still an issue.)

I was a victim of these doctors. I escaped. The police **do not** believe me, nor **try** to stop them hurting others. Please, accept this second chance - and revise your decision, before it is too late.

I am 80, and the *luckiest man to be alive*. I *can see!* (one eye) My wife & children love me and I am productive. From the song, "there is a New world they call the promised land, and I will be there, some day." Before I am forced to leave, can *you* give this world **your** care? The police **make** justice prevail, from **your conscience?**
