Dear Sir, No name given by telephone, ("Mr. James refers.)

In my original appeal form I asked for my complaint to be investigated by the IOPC due to a) the seriousness of the charges (attempted murder by proxy) and b) the local integration of the people concerned.

Mr G Lemon decided it was "suitable for local resolution." (Please see copy of his letter encl. and my reply.)

As briefly as possible: Two doctors I respected and trusted made me blind, with incorrectly timed medication. They refused to help correct this sending me home blind. With the help of my GP I recovered some sight and showed how to the two doctors. However what they had done to me was deliberate. Fearing exposure they "doubled down" to get rid of me, permanently, by means of an excessive MRI head scan and eye stab.

I complained to the NHS (Mr Purt CEO) whom, based upon lies told by the doctors and to avoid any legality denied they had done any wrong, blaming me for my blindness and head pain. Said I had "done it to myself." I wrote to the GMC explaining accurately and honestly what they had done and, after several letters and considerable time, the GMC denied it all. Invariably their replies of denial skirted the *relevant* issues, of what these doctors actually *did wrong* and, filled their pages of reply with incorrect inconsequential misdirection.

Proven (beyond doubt) with 30 A4 medical papers, documents, etc. these two doctors had acted: 1. Contrary to the medical procedures of both the NHS and the GMC. 2. Contrary to the directives (formulary) of the GMC. and 3. Contrary to the *many* medical documents found online. One a professor of eye medicine. (prof. Hayreh)

The GMC staff belittled *all* that I had written; then denied the truth of it. Finally basing their replies upon the words of an *anonymous* "examiner" whom (if existing!) showed little to no medical knowledge. I.e this person sang off the same hymn sheet, and was likely directed to do so. Please note: throughout, these doctors lie *for effect*. I submit: The GMC were, *anonymously*, *directed* to discredit me, in any way they could to deny my complaint. Now, I swear to God I write the truth the whole truth and, nothing but the truth. I ask: e.g. what consultant of any merit would *need* to make untrue defamatory remarks about a patient? All untrue; lies.

Please imagine a near 80 year old man, with *perfect* eye sight for my age (could read down to the bottom line of the eye chart, each eye) being *made* blind within a few weeks of their "treatment" by these doctors, whom then *sent* me away - blind; saying there was *nothing* he could do. Nothing! I said this is unacceptable went home and cried. A professor of eye treatment explained what they had done. Prescribed Lumigan at bedtime. A perfectly *correct* medication but: miss-timed. It should be used <u>no later</u> than the evening. He also wrote there was a cure! I returned with these papers to help them and asked the doctors for the cure.(75% success rate!) They refused me. Yes, doctors have a right to prescribe whatever they believe is correct for the patient; so when *they* refused it I asked my G P. for it. He gave it to me and within 24 hours my sight improved! Thank God! I *could* see again! Not as well as I used to, but.. in the kingdom of the blind... it was like a miracle.

I took the papers to the two doctors; flush with success, *naively* thinking this would be of great help to them. The consultant rubbish-ed the papers saying there were many such on the Internet. (later he admitted he *already knew* them) My big mistake, because they *wanted* me blind; I did not know this at the time; and they decided to do something far worse. Still trusting them and believing what they said; he said there may be some thing at the back of my eyes and a MRI scan is needed to find out. He said it was perfectly safe, like a X-ray, and would be perfectly ok. I had his MRI head scan and, it lasted *80 minutes*; by the clock on the wall. The radiologist had to lift me off the table and, unable to stand I had to rest for a while. During this time I asked her "why so long"? She said "the scans were done as ordered by the consultant; I would have to ask him." Within the hour the head pain started. The worst "headache" I have ever had, lasted for 3 years! Blind,& pain!

Meanwhile, Dr Paul *pretended* to take an E.P. test; put anaesthetic in both my eyes and stabbed one eye; all in less than one minute. A fast brief "attack" efficiently done. I only knew when the anaesthetic wore off. This eye pain was terrible; night and day, for months. At times I seriously considered taking out my eyeball, the pain was *so bad!* I struggled with the head and eye pain. In the belief this *could not* last forever to keep me going. I could still see! But with only one eye. Like the NHS, the GMC, and now, the police, *refuse* to investigate?

The point was and is, the "treatment" by these doctors was **deliberate**. Not accidental, nor negligent, seriously **deliberate**. Deliberately thought out by them and executed to cause me personal **grievous bodily harm**. Culminating in attempted murder (80 min. MRI head scan) in order to "**stop me reporting it.**" <u>Permanently</u>.

May I reassure them, if I die tomorrow, I have requested my successors to continue this prosecution after my death. i.e. posthumously if they will. Simply because no one else should suffer like I have at their hands.

Please understand my dedication to this cause. I had excellent eye sight, a useful and productive life, with a loving family. These doctors made me blind, motive unknown, and subjected me to an horrendous head MRI scan. All *unnecessary*; all *illegal*; contrary to GMC rules; and *lied* to cover it up. Unacceptable for anyone.

The NHS, a good service I do not wish to discredit, stood by their employees based upon their lies. The GMC whom do have the ability to stop them, refuse to do so. They **know** what these doctors did, was wrong. Yet let them continue. The GMC are **complicit willing accessories** allowing them to continue. I did expect the local police to investigate my complaint, rightly so. To seek confirming evidence to enable their prosecution. But: They will not. As Mr Rees said, "it would affect to many people" i.e. the police **refuse** to act on my complaint and thereby, **support these doctors**. In this, Mr Rees did "confine himself to the decision making rationale." I appealed to Mr Huw Davies and hope he will have the courage to "break ranks" and expose these doctors.

I delivered my complaint file of some **30** A4 pages by hand to Aberystwyth police on 28th August 2018. At reception, on my request for a receipt or a reference number, he refused to give me one, saying none was necessary. I asked him to ask the CPS to acknowledge their receipt please. None came. I phoned the CPS and they said they had not received it. Without a ref. number they could not find it. I again rang Aberystwyth and a PC said my file was mislaid, *lost.* No one knew where. No idea where. I said I would supply a duplicate copy. In December Mr Steve Davies telephoned me to say he now had the file (probably the duplicate.) and was appointing Mr J Rees to the case. Mr Rees phoned me on the 12th Feb. 2019 at approx. 5 p.m. his call lasted over an hour. He said he could not pursue the complaint "because too many people were involved.." (or words to that effect.) The *whole call* was to explain and convince me that he would not pursue it. I said it was *deliberate attempted murder* by proxy. A genuine honest complaint of a serious offence against my person. Proven in the ample file of 30 A4 documents supplied. He said he *could not* pursue it. Period. At the end of May he put this in writing saying "*this would not be investigated, no crime was committed.*"

Please accept my complaint file addressed to the CPS had: not been given a ref. number; " *lost*" by the police staff (admitted.) given a duplicate (supplied) which they had *no intention* to ever pursue; and finalised this in writing to say: "No criminal offence committed, not to be investigated." Insult to injury. Also: I had asked the IOPC investigate this, my request is revoked; referred back yet again to the local police. I submit: this was and is obstruction from day one. The perversion of justice. Upon my genuine valid accurate and true complaint.

There is *no* pleasure *nor* reward for writing these letters. These doctors lie and have already discredited me. Complaining will not restore my sight. So why do I do it? At 80? Because:

- I try to stop anyone following after me getting hurt (destroyed)the same way by these doctors. Trust abused.
 They should clearly know they are *not* above the law; and should follow the directives of the NHS & GMC.
- 3. They should respect any patient's trust in them and not, in any case, make defamatory remarks about them.
- 4. Their words carry a lot of weight, second only to the captain, and people believe and trust them.
- 5. The GMC and the police should enable justice, without prejudice, to neither the doctors nor the patient(s).
- 6. The victims who write in to complain will have a a reason to do so. The GMC should not deny them.
- 7. I do not blame the NHS because they erroneously supported their employees, based upon their lies.
- 8. My life has been destroyed by these two men, or nearly so. I am still blind in one eye, so although I can see, I have no perspective. I collapse occasionally (loss of balance) due to the head scan; this is not improving.

Do I really need more reasons to write-up these doctors? The police say: " *no crime has been committed!*" I trusted them, they abused the trust and, they have treated me murderously. There is reason to believe they have done it before, but that is hearsay. They have definitely done this to me and, unless the police stop them, they *will* do it again, with impunity. Safe from even any police action. Meanwhile I remain blind in one eye, suffer black outs and falling over (loss of balance) yet feel very lucky to have survived their efforts to make me completely blind (or dead) and thankful I am *able* to bring this to your attention.
