## For the attention of The Chief Constable (and Crown Prosecution dept...)

Dear Sirs.

Your telephone CPS advised me to contact you and ask you to advise and guide me please on prosecuting the persons named below because I have never attempted anything like this before.

I was made blind and seriously hurt (personal injury) by the 2 doctors named below. I contacted the community council which wasted a lot of time. I reported them to the NHS, - and the CEO, based upon the miss-information (lies) of these doctors said; It was my own fault! The NHS denied my complaints, with no action seemingly taken in regard to what these doctors had done. I explained in detail several times by letters to the Manchester GMC what they had done to me. The GMC denied all my claims with contempt; and refused to name their Registrar, the Assistant Registrar and the Medical adviser, upon whom they based their denial of my letters of complaint.

Now I believe the police are my only last resort to prevent these doctors from mal-treating others like they have me. I add; their actions are not medical accidents; nor negligence; but carefully planned, deliberate, vicious, personal assaults; being <u>fully aware</u> of what they are doing, - to cause needless injuries of blindness and lasting pain. Then, to cover it up with attempted murder by proxy. And not a mark to be found or seen. Their mal-treatments had <u>no medical foundation</u> being contrary to the GMC formulary, and many medical papers by professors of medicine. Just like a boxer could use his fists, these doctors used their medical knowledge, training, and expertise to inflict serious personal injury upon me. Deliberately, viciously, needlessly. <u>Evil.</u>

There are two certain witnesses. 1. The staff nurse who attended at all their treatments and 2. the radiologist who completed the MRI head scan to the consultant's instructions. (thank her for me.) Unfortunately both may be hostile - in fear of losing their jobs. In defence of my limited evidence, I ask, who ever attends their doctor's appointments with the intention of collecting evidence? The details of all this was again reiterated by me, to the GMC, in writing, by recorded delivery. Please see the copy of my last letter to the GMC enclosed. (ignored by the GMC) Copies of all letters can be supplied if required. Therefore may I ask you please to prosecute:

The Consultant: Mr M. Kulshrestha: for his attempted murder by proxy - by his MRI head scan. His Assistant Doctor: Mr. R.O. Paul. - for GBH. - Deliberately stabbed my eye in pretence. The GMC Registrars, their Medical Examiner, and Ms C. Binks Exec. officer, as accessories. For years they have denied my many explicit, accurate, and honest, letters of complaint and have allowed these doctors to continue. i.e. The GMC are fully complicit with all their mal-treatments, have allowed them to continue, and thereby are accessories to the harm that they do.

What can *anyone* do to convince organised authority? When they deny it all, in self-protection? With their expert knowledge it is likely they *can be* excellent doctors; instead, they chose not to. Only they know the reason why they harm *some* patients. Experiment? Dislike? Only they know.

If you can help me to prevent more patients being hurt by them please advise me, thank you.
