But is this true? Or only a GMC rhetorical PR facade? Do you apply your own rules?

I swear on oath the following to be true:

Upon referral to Aberystwyth eye clinic I was seen by Consultant Mr. M. Kulshrestha & Dr R.Paul his assistant. After their examination the consultant said I had an e.p. of 22 and 24. (approx.) and, if this is not reduced I would develop Glaucoma. Irreversible, with no cure. (These actual numbers are not as the NHS report it.) I had perfect eye sight for my age; I could read to the **bottom** line of the eye chart with <u>each</u> eye; and had passed for flying (prov.) etc. Therefore: he <u>could</u> (or should) have said: "come back in 6 months and we will test you again." Instead, he worried me with the threat of Glaucoma, saying "it was important I put one drop of Lumigan in each eye at **bedtime**."

This, his instruction, I obeyed. He repeated this instruction of one drop in each eye at bedtime at every frequent examination. In fact so often, one time I asked "why bedtime?" The reply was it is the "optimum time" for the Lumigan to work. Following his prescription, a few weeks later I awoke one morning, blind! My GP returned me back to the clinic and I asked the consultant "why"? Why had I now gone blind? After his re-examination he replied: "You have NAION. This can happen to anyone at anytime. It has *nothing* to do with the Lumigan drops, a perfectly normal medication." And, "there is *nothing* he can do to correct it. There is no medication to cure it, and I would likely lose all of my sight *permanently*, soon." Go home. (blinded) "There is *nothing* he can do for me." I said in reply: This was unacceptable. My eye sight *had* been perfect. He had prescribed me into using Lumigan drops to "save" me from Glaucoma and, made me blind! Now, <u>refusing to help!</u>

I researched the treatment he had prescribed and what he had said to me, and found on the web several published medical papers, one by a *professor* of eye medicine, who categorically writes:

1. Lumigan eye drops, a *perfectly* correct medication for elevated eye pressure, *has* to be applied no later than in the evening. A fact born out by the GMC formulary of which this consultant *would* be aware. Application later than evening can almost certainly cause awakening blindness. NAION.

2. If treated within 14 days (the "window of opportunity") a 75% success cure rate can be obtained. I returned to the clinic to inform the consultant and to ask *please* give me the medicine to cure me. He rubbished the papers; saying there are lots of them. He refused to give, or *even discuss*, with me *any* medication, or help, whatsoever. Just go home, blind. This, from my *Consultant Doctor*.

Mal-treatment No. 1 His miss-timed medication - well known to instigate NAION. (blindness)

A week or so later Dr Paul said he wanted to take an e.p. reading, like he had taken several times before. He put anaesthetic drops in my eyes, my head on the machine cradle, placed an object on the end of the probe, and punctured (stabbed) my right eye. He removed the object off the probe, returning it to his left hand jacket pocket as he rose up from his chair, and rapidly left the room. All completed in less than 1 minute! He has not seen me since he did this violent assault upon me. When the anaesthetic wore off the pain in my eye was **intense**. Like a toothache; only one I could not remove. This intense pain lasted for **4 months** and at one point after 3 months, the pain was so bad, **day and night**, never ending, I was tempted to take my eye ball out! It was only the single thought - once out, my eye could **never** get better, that stopped me. My eye is *still* sore to this day. This was a <u>cowardly underhand physical injury</u>. Deliberately done. Abusing my trust for the doctor. Note: No readings were taken nor written down. The injury pain, delayed by applied anaesthetic. His **speed** of execution revealed a planned vicious assault. One without any medical foundation. **Mal-treatment No. 2** A criminal personal assault, meant to cause eye injury. (damage)

Now the consultant said he required an MRI head scan. He said to me "there may be a fault at the back of my eyes and, he would like an MRI head scan to see if there was a problem." I reluctantly agreed to his insistence because I still hoped he would help me (he is a consultant!) He said it was perfectly safe, like an X-ray. He just *may* be right, and be trying to help me? *Still*, I believed in him!

I attended for the head MRI scan, lay on the table with my head in the cradle at just after 9.10 am. My appointment was for 9.15. but I arrived a few minutes early. The scanner ran continuously for 80 minutes, until 10.30 a.m. (by a large clock over the doorway.) I had almost passed out, but, the machine stopped buzzing and the lady *lifted* me off the table. I was *unable* to stand for a while and had difficulty leaving. While I rested I asked the lady (radiologist) "Why had it taken so long?" The lady replied: "The scans were done according to the Consultant and I would have to ask him." Soon after leaving the head pain started. My head felt steel "bound" *and* trying to burst. The worst head ache I have ever suffered. This pain lasted day and night, for *three years!* Trying to get *any* respite from this head pain was impossible. These doctors now decided to *never* seen me again.

Mal-treatment No. 3 MRI H/Scan: Criminally excessive multiple scans to inflict personal injury.

Back at home, blinded and in <u>severe</u> head and eye pain, these doctors now reported: I was a druggie; I had demanded medications; that I had missed appointments; etc. **All untrue!** <u>Slander</u>. All just to discredit me; to justify removing me off their list. In only a few months, these two doctors had made me, a man in good health and excellent eyesight, blind and in <u>continuous severe pain</u>. Then, <u>decided not to help me in any way</u>; to slander me to the NHS; to discredit me. **Why?**

Allow me to explain why. It has taken me three years to get free of the head pain and, while I still suffer the side effects of his MRI head scan, loss of balance, e.g. falling in the street / roadway etc. and other side effects, the head <u>pain</u> is *mostly* gone now. I am still blind in one eye, which remains sore from the deliberate, vicious, physical stabbing committed by Dr Paul. It took me another year to overcome my total disbelief and reasoned why. To realise why **any** person, especially doctors, could be so cruel to anyone this way. The reason was realised in March of this year. <u>This is why.</u>

Consider *their* position: They are expert trained and well informed consultant doctors. They *know full well* what they are doing. They do this <u>every day</u>. i.e. prescribe Lumigan and order MRI scans. As a *consultant* he would be aware of the formulary rules and, he admitted to me when shown the medical papers, that he had knowledge of them and the contents. These he <u>had</u> to rubbish. Why?

Because (in mal treatment 1.) he had clearly *miss-timed* his Lumigan medication, saying bedtime, instead of evening. A number of excuses can be given for this but, for a consultant who prescribes this *perfectly correct* medication daily, are *any* of them likely? No. So, was his prescription of the *bedtime* application for me deliberate? *Knowingly* contrary to the medical formulary? I believe so.

For now; let us give him the benefit of the doubt. When I showed him the medical papers clearly condemning his miss-timing and contrary to the formulary, he realised he was in trouble. What can he do about it? If he admits it was an "accident" he would be incompetent. And, if he denies it, to explain is even worse, it would be seen as deliberate. He <u>had</u> to find a cover-up solution. He did.

I believe he colluded with his assistant Dr Paul such that, if they could create a "defect" in my eye it would cover up their miss-timed Lumigan drops. Better even; if they could induce a head related "illness" connected with my eyes, this could completely hide what they had done. They decided to do both. Dr Paul would puncture my eye to cause sufficient pain and damage to push me to forget the miss timed Lumigan with a *real* pain in my eye. If this failed, their "own induced, head related" illness e.g. a stroke seizure embolism or similar, would give them an excellent medical "cover up."

Hence his head MRI scan. This consultant *knew*, by ordering sufficient multiple head scans, he could induce a stroke, seizure, or similar head-eye related "illness." One to render me incapable of making any coherent complaint, and, his plausible excuse for the blindness he had instigated. With luck, this could cause my premature death with no blame on them, - then it **all** be forgotten. All he had to do was.. get me to have an MRI head scan and, order multiple scans, to do the job.

They do not **think** they can get away with it, they **know** they can, with your support.
