Dear Mr. Steve Davies (and Mr J. Rees),

Thank you for your letter dated 1st May 2019. By your letter (copy encl.) you confirm you chose for the CPS not to proceed with the prosecution of my complaint. You disappoint me. To not even register it.

I contacted the NHS with my complaint and, fearing compensation claims, the NHS dismissed my complaint and, based upon the lies of the doctors. (libel) Mr Purt CEO stated: "I had done this to myself."

I contacted the GMC and explained accurately, explicitly, and honestly, the treatment of these two doctors. The GMC executive and staff belittled and denied all my complaints replying these doctors had done no wrong. Even though their treatment is contrary to the GMC formulary and many published medical papers.

I contacted the CPS requesting your help in prosecuting the actions of these doctors, for the safety of others. The CPS (Mr Rees) made one phone call to me expressing his opposition to the prosecution of my case against these defendants and by letter, finally closed the issue without even recording my complaint.

The consultant Dr Kulshrestha's with:

Attempted murder by proxy. Code 2 Violence against the person. Violence with injury (MRI head scan) His assistant, Dr Paul with Code 5D Violence against the person. Violence with injury. (stab in the eye) The GMC Exec. & staff, charge: Accessories to 8N Violence against the person with injury. (complicity)

I believe my complaints are valid because:

- a) These doctors caused me years of blindness, serious pain, and ongoing harm. (loss of balance, etc.)
- b) Their actions were contrary to the medical formulary of the GMC whom have never admitted it.
- c) Their actions are clearly stated in the many published medical papers (supplied) one by a professor of ophthalmology of which at the time they were fully aware, as seriously harmful. (for anyone) i.e.
- d) They were fully aware of the physical damage, pain and harm (blindness) their actions would cause.
- e) No remedial actions were offered. He said: "He could do absolutely nothing." (Not true, lack of care.)
- f) They reported me to Mr Purt CEO. Claiming I was druggie, demanded medications, and missed appointments. etc. All untrue. (slander / libel.) To provide an excuse to remove me from their list.

Dear Mr. Steve Davies (and Mr J. Rees)

Mr Rees derided intent. It took me over 4 years - from being a simple soul believing all doctors "did good," through suffering, blindness and pain, to that of - Why? Doctors refusing all help. Not once, but twice, they sent me away saying "they could do absolutely nothing." Go home, blinded and in pain.

Their dismissal closed my doctor-patient relationship. Then, they said they would help, and:

- a) under his cloak of an e.p. test, Dr Paul stabbed my improving eye, creating more damage and pain.
- b) Dr Kulshrestha ordered continuous MRI head scans taking 80 minutes. Double the normal time of 40 minutes. Exceeding by far the <u>maximum</u> safe limit of 60 minutes. All this they did because they had told me to use the Lumigan eye drops at bedtime. A well documented method to cause NAION. (blindness) The doctors knew it; the GMC knew it; (the GMC specify no later than evening.) When I naively showed them the papers they knew then, I also knew it; and they had to do "something" to stop me reporting it. All the rest was to cover-up. These doctors can now continue selectively providing the same treatment.

Like a carpenter could use his tools to damage my eye and a hammer to damage my head; these doctors, I submit, used their knowledge and "tools of their trade." An head cradle and MRI scanner, to seriously harm me. The excessive head scan to cause a stroke (or similar) to foster death. Their intention was to kill, by proxy. The eye stab was masked by a pretence of taking an eye pressure reading with no records being made. There was no justification nor care in their actions. It caused three years of pain, more loss of sight.

As doctors they are clearly mentally ill; to deliberately blind and harm another person. I see no reason for them to selectively continue damaging others in a similar way. The way to stop them is by being removed from the register. The GMC refuse to do this. The GMC are complicit with and accessories to their actions.

You can understand I find no justification in Mr Rees's refusal (for the CPS) to acknowledge the harm done by these doctors. I submit: my prosecution was a just and measured response to their criminal actions.

Please try to understand: it is not what they have done to me; it is what they can do (and have proved to do so) to anyone they choose, and, the GMC allow them to get away with it. It is necessary for public safety to see their treatments are stopped. The GMC have refused to stop them. Nor will the CPS.

I looked to the CPS to see the validity of my case and to save others by bringing these two doctors to justice. If they did it to you, would you like them to continue? Now the CPS have refused to help, and worse refused to register their crime. Unfortunately I cannot save this world alone. The last person to try was 2000 years ago and look what happened to him! It's *your* world. I leave it to you; with this quote by Myers:

"In the face of recognised evil can any man absolve himself from not taking action."

I will not trouble you **any** more, and hope to live the years I have left. As a victim, I have tried to inform you. Yours most sincerely,
