Dear Mr. S. Davies,

Further to my letter of the 8th of this month. Without seeming to direct your investigations may I suggest Mr Reese may wish to ask them the following questions and not be influenced by their position or standing.

- 1. Why: did he specify (at every examination) I put the Lumigan eye drops, one in each eye, at "bedtime." This is <u>not</u> the correct timing; which is "no later than the evening." See the GMC. (I have a recording.)
- 2. Ask him why: when I showed him the Medical papers from Professor Hayreh (of which he later admitted being aware) which states *conclusively* that Lumigan should <u>never</u> be applied at bedtime because it can cause NAION; awakening blindness; this he did, in my case. The GMC formulary states *no later* than the Evening for this Lumigan application. And, as a *consultant*, he would be aware of this ruling.
- 3. Ask him why: he refused to assist me when I returned to him blind and naively showed him the papers? While he has a right to deny me any medication, why did he refuse to **discuss** any means of restoring my eyesight? This by a consultant. Was it because he had achieved his intention? Now blind.
- 4. Ask his assistant Dr. Paul, why he used the **pretence** of taking an eye pressure test to stab me in the eye? He had no records; he made no reference to the reading; (normally he would have) He made no notes of it; and only **pretended** to take the e.p. of one eye, after placing anaesthetic in both eyes? Was his charade of an e.p. test to facilitate his "stab in the eye?" Yes; without question or opposition.
- 5. Ask the consultant why: He said his MRI head scan was perfectly safe and then ordered *multiple* scans to require 80 minutes in duration? He *knows*, as a consultant, how long these head scans take; approx. 40 minutes. So why did *he order multiple head scans* to take 80 minutes? Ask him why? (Verified at the time by the radiologist who confirmed, "You would have to ask the consultant.")

These scans were *twice as long* as a normal scan, and *grossly, dangerously, excessive*. Why? Scans beyond the GMC formulary of 40 minutes. The *maximum time* allowed is 60 minutes. Why did he order multiple scans to take 80 *minutes*? Twice the normal time and, sufficient to cause a stroke, or embolism, and likely death. Why did this knowledgeable **consultant** order these **grossly excessive dangerous** multiple scans? I suffered permanent headache for 3 years. He nearly killed me.

Can the consultant answer these points to your satisfaction? Because if not, you will know they are guilty. I cannot teach you your job; but apply the litmus test; if it were you, your wife, or anyone! Would you wish them to suffer these actions? To be blinded, and your life destroyed, like this? **Simply Evil**.

They destroyed my eyesight. When I naively showed them how (and how to put it right!) they decided to finish me, once and for all. With the stab in the eye, and *grossly excessive* MRI head scans. Attempted murder by proxy. Would you like to be their next patient? They *know* what they did; they know, I know. Please, charge them and stop their evil. If not for me, for all who follow after me. Dear Mr. Davies,

Today received a telephone call from your colleague Mr Reese. He confirmed he would not proceed with my case. I believe he arrived at this decision in error and, I will appeal. Briefly: His arguments were:

- 1. The only reason he gave was too many persons of professional standing supported them? (he cited 9-10 in number, Dr Barr, etc.) And, that I should pursue medical negligence. (which is time expired.) Medical colleagues do stand together. To quote numbers in the same profession is not a valid reason to presume innocence. They may like him, will not criticise his work, and therefore are incapable of giving an unbiased assessment of his guilt. (or innocence) A ballot box "vote" does not make him innocent. It is as if you asked a blind man about a colleague, "what did you see"? Nothing, would be the reply
- 2. I have sought the assistance of the NHS, and been called a liar. I have sought the assistance of the GMC, who belittle me and deny it all; saying these doctors have done no wrong. This is *simply not true!* If a plumber had blinded me with a pipe, or a boxer with his fists, would you view it differently? Simply because they are doctors does not mean they are innocent of this violence; in fact, they have a much easier way of concealing it. I have detailed what they did which was contrary to both the GMC formulary and the many medical papers supplied. They were *criminally wrong* to treat me (or anyone) that way.
- 3. Their actions were deliberate. Not accidental, not negligent, but *deliberate*. These doctors are well trained consultant professional men who are *fully aware* of what they have done, and are escaping justice by the police refusing to charge them. I cannot make you charge them; if you do not you pervert the course of justice. They prescribed Lumigan and order MRI head scans *EVERY* day. They know the effects completely. They told me to use Lumigan at bedtime. (a recording to this effect) and later, did order a multi-scan MRI head scan to *knowingly excessively exceed* the statutory safe limit. This was a direct attempt to cause my death by proxy. Also: From the start to the finish he lied to me. And now, he lies to you. *Please*: stand up to them. I swear to God, I tell the truth.

I look to the police for justice. Not only for myself; for the people who follow after me. The police are my last resort in bringing a prosecution, and yet you refuse, because you do not want to ruffle "feathers"!

I look to you, the police, to be upstanding and rightly denounce their evil; to bring them to book. To see justice is done and not perverted. *Please*, do not let them get away with this. They will do it again if you do not stop them. I beg you - to do the right thing and stop these doctors blinding and attempting to kill people. It's that simple. You *need* to do this. To send a clear message; that they cannot escape justice.

I ask for nothing. No money, no help with my eyes, nothing at all, only they get stopped. (charged) Yours most sincerely,
